By signing below, I acknowledge that skiing, snowboarding, racing and related activities are HAZARDOUS activities and that I have made a voluntary choice to participate in those activities despite the risks that they present. In consideration of my being permitted to participate in the event named above, I agree to ASSUME ANY AND ALL RISKS OF INJURY OR DEATH which might be associated with or result from my participation in this event, whether competing, photographing, or filming.

I further agree, having acknowledged the risks of the activities I or my child/dependent am about to participate in, hereby waive, without limitation, any and all claims for injury, liability or damage against **Independence Racing** arising out of its negligence or the negligence of any of its agents or employees, and hereby RELEASE FROM LIABILITY, INDEMNIFY AND HOLD HARMLESS **Independence Racing**, its affiliates, officers, directors, agents and employees, land owners, event organizers and sponsors from any and all liability of damages arising out of my participation in these activities and programs.

I CONTRACTUALLY AGREE that ALL claims for injury and/or death shall be GOVERNED by IDAHO LAW and EXCLUSIVE JURISDICTION shall be in Idaho state court with venue in Bonner County Idaho.

I, the undersigned, have carefully read and understood this agreement and all of its terms. I understand that this is a RELEASE OF LIABILITY which will legally PREVENT me or any other person from filing suit or making any other legal claim for damages in the event of my death or any injury to me. I nevertheless enter into this agreement freely and voluntarily and agree that is binding upon me, my heirs, assigns and legal representatives.

If I am signing on behalf of a minor and I accept full responsibility for all expenses incurred as a result of the minor's participation in Junior Starlight or recreating at Schweitzer. I agree to RELEASE FROM LIABILITY, HOLD HARMLESS, and INDEMNIFY Independence Racing, NASTAR and Schweitzer its affiliates, officers, directors, agents and employees, land owners, event organizers and sponsors for any claims brought by or on behalf of my minor child(ren)/dependent(s), including negligence claims.

Furthermore, I hereby grant to Schweitzer, and their legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs and videos of me, or in which may be included, for editorial trade, advertising, and any other purpose and in any manner and medium; and to alter the same without restriction.
